

NEW GRETNA OLD HOME SOCIETY, INC.

REGULATIONS PERTAINING TO THE USE OF BURIAL LOTS ,BY PERSONS WHO BUY LOTS IN MILLER OR HILLSIDE CEMETERY, NEW GRETNA, NEW JERSEY.

- (1) The Family Memorial Monument shall be placed so that the front surface of the Family Monument on which the memorial engraving is carved shall be parallel with and face the adjacent roadway. It shall be placed on the plot as follows:
 - (A) In plots with 2 rows of graves, one above the other, the center of the family stone is to be placed at the diagonals drawn from the comers of the plot.
 - (B) In plots with one row of graves, the-center of the family stone is to be placed at the top of the graves midway between the top corners of the plot. No tombstone shall be placed closer than one foot from the side boundary of a grave or grave plot.
- (2) The grantee of the burial lot is also prohibited from planting or transplanting any flowers, shrubbery, trees, or any other botanical organism on the lot or placing anything on the lot other than a Family Monument, an individual headstone and/or footstone, a veterans monument, or corner lot markers or permitting or employing anyone else to do so without the express written permission of the New Gretna Old Home Society Board of Directors.
- (3) The placement of caskets or coffins in the burial lot is prohibited unless such casket or coffin is enclosed in an approved vault in conformity with the laws of the State of New Jersey and the regulations of the New Gretna Old Home Society, Inc.
- (4) The person who is authorized to render the service of grave digging shall first remove carefully the grass sod required and replace the same grass sod in, a position so that the surface, of the-ground over the concrete vault will be level. Any elevation or depression of the ground surface, is prohibited.
- (5) Mausoleums are prohibited.
- (6) Plot sales of less than four graves are restricted to Section E of the Crate Section unless waved by the board.
- (7) No more than one casket may be placed in a grave. There is a limit of two additional cremains burials on a grave with a casket. A maximum of three cremains burials may be placed on a single grave with no casket, however, only one monument allowed on grave with enough room for 3 inscriptions.
- (8) A Monument Work Permit Application must be approved by the New Gretna Old Home Society before the installation of any monument and/or corner markers. An approved footing, installed by a designee of the New Gretna Old Home Society, must be in place prior to the monuments installation. We recommend that you contact the Old Home Society prior to ordering a monument to insure that the monument meets the Old Home Society specifications.
- (9) All burials, including cremains, must be done under the supervision of the New Gretna Old Home Society. The submission of the appropriate Burial or Cremation Permit along with the accompanying Burial Permit Fee is required.

The Board of Directors of the New Gretna Old Home Society reserves the right to change, alter, delete, or add to these regulations as circumstances warrant.
